The objective of the side-event is to deepen the discussion among various actors on Article 27 of the CRPD with particular reference to the estimated 3-4 million people living with visible impairments or disabilities due to Leprosy. Through this side-event, we aim to ensure the inclusion of socio-economic concerns of people affected by Leprosy in the larger disability agenda for 'Building Back Better' amid the 'COVID-19 response and recovery' and the need for States to provide equal work, employment and livelihood opportunities for them to 'live independently' and be 'included into the community'.
